- > IT specialist services DPS
- > IT specialist team services DPS
- > IT infrastructure equipment DPS
- > IT systems development and maintenance services DPS
- Software DPS

*DPS quotation deadline means that you may connect and submit requests for participation to the Centre of Registers at any time by the end of this period to be added to the DPS. Candidates who meet the qualification requirements set by the Centre of Registers and do not have grounds for exclusion will be added to the DPS and in the future the Centre of Registers will invite these participants to submit specific tenders and award contracts under restricted procedure.






How does the Dynamic Purchasing System work?

Established period of DPS validity (e.g. 3 years)

Main stages of the Dynamic Purchasing System:

Stage I of DPS: The generation of DPS (all candidates who meet the qualification requirements set by the contracting authority may participate in the Dynamic Purchasing System and the number of candidates is not limited):

- Centre of Registers announces the ongoing DPS and related documents;
- Tenderers file DPS requests for participation which can be submitted during the entire duration of DPS;
- Centre of Registers verifies the tenderers' requests for participation, including qualification data and information on the absence of grounds for exclusion;
- Centre of Registers adds tenderers which meet the requirements to the DPS (or its specific category, if applicable).

• Please note that the Centre of Registers may, at any time during the DPS validity period, verify whether tenderers meet the qualification requirements and have no grounds for exclusion, meaning that the Centre of Registers may request tenderers to submit updated documents confirming the absence of grounds for exclusion at any time during the DPS validity period.

- Tenderers are obliged to notify of any changes in their qualifications or grounds for exclusion during the entire DPS validity period.
- Tenderers may withdraw from the DPS at any time by notifying the Centre of Registers.

Main stages of the Dynamic Purchasing System:

Stage II of DPS : Execution of a restricted procedure on the basis of DPS (for the award of each specific procurement, the Centre of Registers, on the basis of DPS, simultaneously sends, in writing, calls to tender for the award of the procurement contract to all the candidate participants in the system, with a request to submit a tender bid):

- Centre of Registers, after having determined the need for the object of procurement during the period of DPS validity, sends invitations to all tenderers in DPS (or its specific category);
- Restricted procedure tendering rules apply to a specific procurement, meaning that only tenderers added in DPS (or its specific category) will be invited to submit tender bids.
- Tenderers then submit bids for a specific object of procurement;
- Centre of Registers evaluates tender bids in accordance with the criteria specified in the invitation, select the winning tender bid and award the contract.
- Before awarding the contract with the tenderer whose tender bid is recognized as winning, the Centre of Registers requests for relevant documentation to support the absence of grounds for exclusion.
- Deadlines for the submission of particular tender bids is 10 calendar days for international procurements and 7 calendar days for simplified procurements. However, if the tenderers agree, these time periods may be shortened.

 \succ The option for tenderers to be added to the system at a later time during the entire period of DPS validity, which may theoretically be between 1 and 10 years, thus ensuring that even newly established entities are added to the DPS have the possibility to submit procurement tender bids;

Significantly shorter procurement procedures and duration;

 \succ Tenderers are not subject to penalties in the absence of a specific tender bid and there is no obligation to participate in specific procurements.

> The number of specific procurements during the period of DPS validity is not limited. Also, several specific procurements can be conducted at the same time.

> The period of deferment for the award of the contract does not apply.
